ORDER :

The draft of an amendment to the Tamil Nadu Boiler Rules, 1972 proposed to be made under section 29 of the Indian Boilers Act, 1923 (Central Act V of 1923) previously published with the Public Works Dept., Notification No.SRO A244-88 dt. 5th Dec 1988 at pp 315-316 of Part III. Section 1 1(a) of the Tamil Nadu Government Gazette, dated the 28th December 1988, as required by sub-section (1) of Section 31 of the said Act for General information. No objection or suggestion having been received the Government hereby confirm the amendment. The appended Notification will be published in the Tamil Nadu Government Gazette.

2. The Works Manager, Government Central Press, Madras is requested to furnish five copies of the Notification to Government for the purposes of record.

APPENDIX

NOTIFICATION

In exercise of the powers conferred by section 29 of the Indian Boilers Act, 1923 (Central Act V of 1923) the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Boilers Rules, 1972, the draft of the same having been previously published as required by sub-section (1) of section 31 of the said Act.

AMENDMENT

In the said Rules, after rule 47, the following rule shall be added, namely:-

"48. Registration of firms to manufacture, erect and repair:-

(1) All firms requiring to manufacture, erect or carryout repairs to boilers, boiler fittings, pipelines of any other component coming under the purview of these Rules shall be registered with the Chief Inspector of Steam Boilers. The Registered firms shall also renew their registration, every financial year,

(2) The fees to be paid by the firms for registration and renewal shall be as specified in the Schedule below:-

THE SCHEDULE

<u>Type of firm</u>	<u>Fee for Registration</u>	<u>Fee for Renewal</u>
(1) Manufacturers of full boilers and major manufactures of boiler fitting.	Rs.500	Rs.250
(2) Boiler Repairers Grade - II	Rs. 100	Rs.50
(3) Boiler Repairers, Grade I, Pipeline erectors, Water tube boiler erectors, foundry forgeshop pipe benders, pipeline fabricators, flange manufacturers, smaller manufacturers of valves, fittings and other categories which do not fall under items (1) and (2) above.	Rs. 200	Rs.100

(3) The firms seeking registration shall send their application to the Chief Inspector of Steam Boilers, Madras 600 004 accompanied with 50% of the fees payable for registration subject to a minimum of Rs.100/- The balance shall be paid at the time of registration. The fees paid by these firms which are found unfit for registration shall be forfeited to the Government.

(4) Organisations owned or controlled by the Central Government or the state Government shall be exempted from the payment of fees.

While priority shall be given for doing erection work to registered firms only, the Chief Inspector of Steam Boilers may accord special permission to other reputed firms within or outside Tamil Nadu for specific jobs for special reasons like -

(a) the manufacturers of boilers prefer to erect their boilers themselves, or through their own agency; and

(b) major jobs for which tenders are floated on an all India basis.
